




Tiny House Village

A group of houses which are compact as a result of **design objectives** and benefit from **common services**.


Individuals within collectives generally hold a **common language** with their cohort. This can be a language of objective or design.











Founded in 1835, members originally pitched tents on the **Methodist Summer Camp.** After several years, members began to replace tents with **small wooden cottages**- eventually **numbering in excess of 300** by the year 2000. Cottages are **clustered together** in small pocket-type neighborhoods, each of which has its own identity.










1909

Popular in Southern California, Bungalow Courts became famous among people who wanted to live in a **house and have a garden**. These courts were made up of **small scaled houses placed around a central open space**. This layout gave people the opportunity to own both a home and a garden but because the idea was centered around a community they now had help to take care of the homes. The communities would be made up of 6-10 small units that create and enclosed area.

This community showed that 8 small cottages could be just as effective as 4 normal size houses. It worked to set an example for what the contemporary pocket neighborhood would look like.






Co-Housing




Co-Housing Nevada City Co-Housing McCamant-Durrett Nevada City, California 34 Units | 500-1600 sqft each

The community was designed to encourage neighbor interactions. Residents can make use of the 4000 SqFt common house which has a large dinning room, kitchen, kids room, and music room.











Canoe Bay Village is the midwest's first large scale tiny house vacation village. The village sits around private lakes with walking tails for visitors to explore.










RV Parks

This RV park is know as one of the top class A motorcoach houses. The park offers many amenities to their residents including 5 different pools, golf course, and an on site dinner.












Disaster Relief Housing Tiny house villages designed to assist with disaster relief efforts by providing temporary housing that is affordable and compact.






Affordable Housing Villages




What makes a well balanced **Affordable Housing Village?**


Four Principles











Bridging the Gap

"Everyone deserves a safe and stable place to call home. However, current practices and funding sources are inadequate to meet the overwhelming demand for affordable housing."

The village model provides an intermediate between the street and conventional housing options.



Sustainable Footprint

"Building small is the only practice that reduces both energy usage and material demand—resulting in lower capital, operating, and maintenance costs over the life of a house. Tiny houses are therefore a cost-effective means to create more housing opportunities with the limited resources available."



Community Building

"The Village Model goes beyond building individual tiny houses. It emphasizes building communities that respect the **autonomy of residents**."


The ability to **maintain a separate home** with separate walls while still interacting with the remainder of their cohort is incredibly important to residents.





